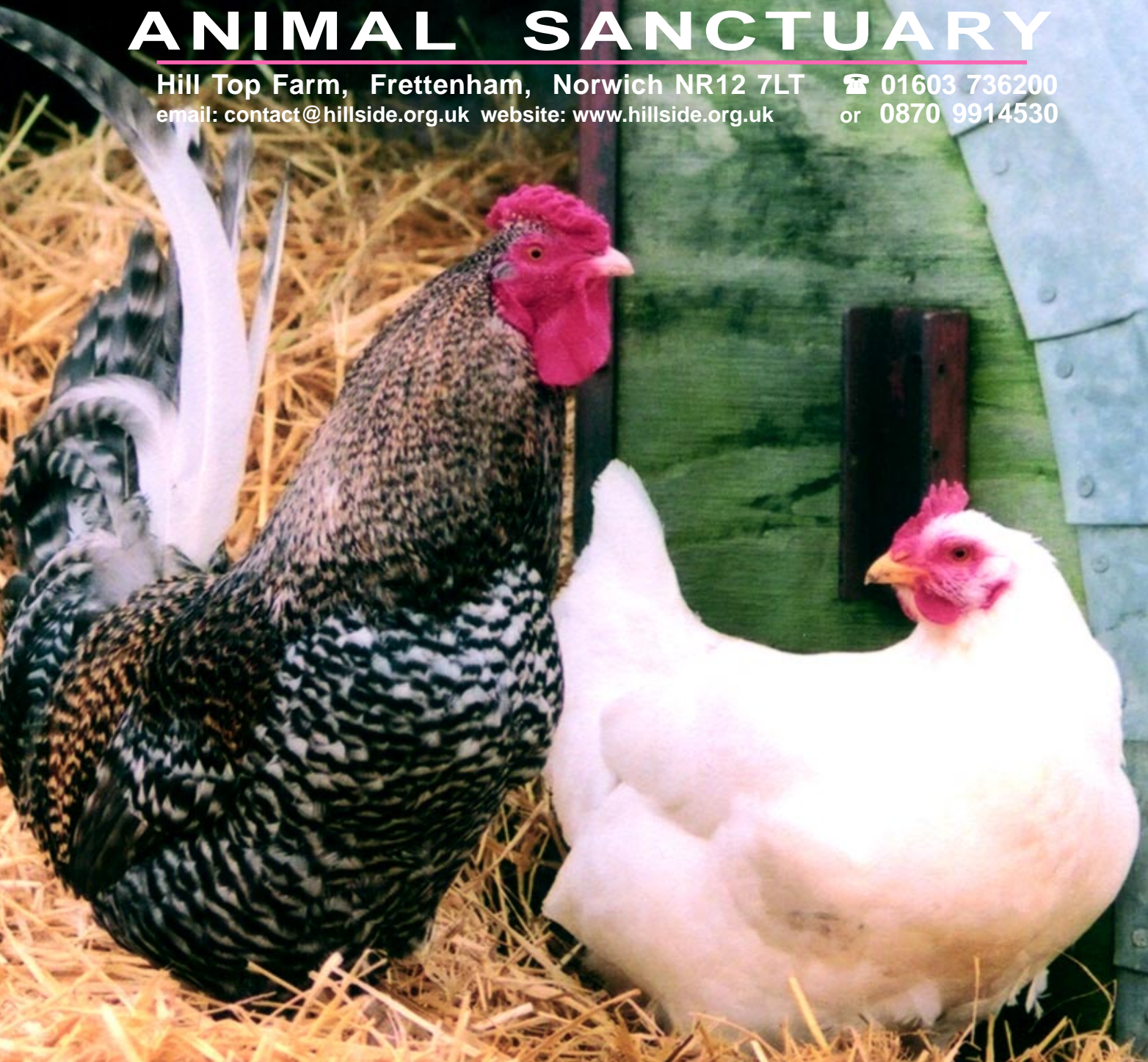

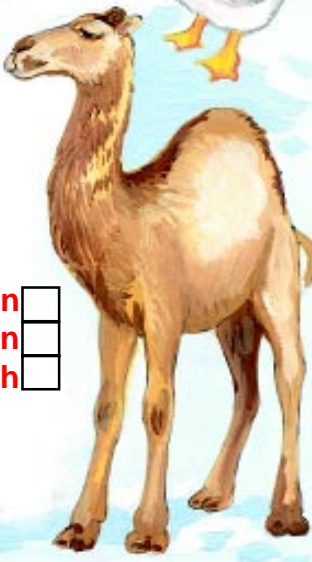

**Zack**



Towards the end of last year we received a call asking us if we could offer Zack the permanent, loving home he so much needed and deserved.

The caller had quite literally bought Zack off the back of a lorry - one destined for the slaughterhouse! Then, having made enquiries, she discovered that he had been a prolific show pony but owing to a leg problem his 'career' had come to an end.

Although his rescuers knew they could not offer him a home for life, the family spent the next year building the confidence of this shattered little pony.

Unfortunately Zack's story is not an uncommon one. We are often asked to take in ponies when they have become infirm or outgrown and are too old to sell on again. Children's ponies can quickly become surplus to requirements, suffering much trauma as a result of being routinely passed from one home to another.

We believe that all horses, ponies and donkeys benefit from a settled environment and should live as near as possible to how nature intended in the company of their own kind.

We are pleased to tell you that Zack has settled in well and is enjoying the companionship of his new-found friends, Pansy, Misty and Jasmine.

**Smokie**



One morning staff

discovered an extra mouth to feed in the shape of Smokie the rabbit.

We found Smokie, pictured here with Anne, abandoned at our gate. She had been let loose and the pet carrier she was probably brought in had been thrown over the hedge at the bottom of our drive. After being given a health check by our veterinary staff, Smokie was taken to quarantine. Fortunately for Smokie hers is a happy ending. So many rabbits, often as the result of being a child's 'five-minute wonder', spend sad lives cooped up in hutches with no company and little room for exercise.

**Bambi**



Last January we were contacted by an employee of a company located at Grimsby docks to report they had a rather unusual visitor who had become trapped in their compound - a young female deer whom they had named Bambi. She had become orphaned after her mother had been hit by a car, leaving her vulnerable and alone.

Bambi was not going to be easily caught and due to the close proximity of the water's edge we could not risk a vet sedating her with a dart, so an alternative idea was put into action. The staff at the compound left food inside a trailer, kindly loaned to us, to encourage the young fawn to walk in of her own accord and be safely captured. Just a week later our plan had worked and Bambi was on her way to the safety of Hillside. On her arrival, to help her settle in, we gave her the company of two recently rescued sheep. Happily, they've become the best of friends and are now inseparable. The vet has given Bambi a clean bill of health and soon she will be released, along with the sheep, into well-fenced fields to run free with our other rescued deer, Baby, who you will already have seen featured in our previous newsletters and greetings cards.

**Angus & Jimmy**



We were pleased to welcome Angus and Jimmy to the Sanctuary after receiving a telephone call from our local Trading Standards' office asking if we could help. These two Hebridean rams had been found running loose on a main road and were being kept safe in a neighbouring back garden. Our Farm Manager, John, duly set off with the Sanctuary's trailer and brought Angus and Jimmy back to Hillside. When they arrived, they were placed in quarantine - our policy for

all new arrivals. We then waited for their owners to claim them but nobody came forward. However, in order to be able to give any sort of veterinary treatment, we had to wait until we became Angus and Jimmy's legal owners. We then arranged for them to have an essential little operation so that they could live 'safely' with our other rescued sheep, many of whom are ewes! We're happy to report that Angus and Jimmy are thriving in the Sanctuary and appear delighted with their new surroundings.

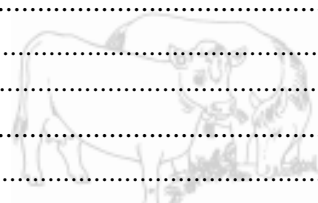

# Hillside Investigations Report...



## UK ANIMAL WELFARE LAWS - NO DETERRENT

In last Summer's newsletter we reported on the successful prosecution of a farmer for leaving decomposing sheep to rot in a field shared with their living companions. The case was brought to court by Norfolk Trading Standards after receiving information from one of our staff. Unfortunately just six months later, our investigators discovered still more carcasses, in a field adjacent to where the prosecuted offence took place.

### The evidence - just left to rot!

In this incident last December, where the remains of two sheep were clearly visible from a major public highway, our investigators filmed the carcasses over a period of three days. During this time no attempt was made by the farmer or landowner to remove and dispose of the bodies despite the fact that they had most certainly been dead for some time before we found them. Whilst filming we noticed a sick sheep who had remained on her own whilst the rest of the flock had retreated across the field. Though we tried to assist the animal, she managed to elude us and when we returned the next day she had died and lay next to the existing carcasses.

This once again raises the question of how effective the current system of regulation and enforcement really is. If just six months after a conviction, a similar offence is happening in the same locality, then surely the penalties imposed are not severe enough to ensure that farmers take the proper measures to protect the welfare of their animals. Legislation is in place to protect the welfare of animals on our farms and is apparently, according to DEFRA, constantly under review. Yet how protected were the sheep that we found, left to die and rot in the open, neglected and obviously unchecked by the person who, **by law**, is responsible for ensuring their welfare?

**STOP PRESS** (March 2004) - as this newsletter goes to print, for the **SECOND TIME THIS WINTER**, we have found yet more decomposing sheep ON THE SAME FIELD. We have again reported these to Norfolk Trading Standards, who confirmed our findings and assured us the offences will be dealt with!

## HARROWING FARROWING CRATES



Following our Pigs Behind Bars article in our January newsletter the RSPCA have responded with: *"The RSPCA shares Hillside's concerns about the use of conventional farrowing crate systems... They (the pigs) are in fact placed in the crate just a few days before they are due to give birth, but then are confined in them until their piglets are weaned three to four weeks later. Farrowing crates are used in order to try to reduce the mortality rate of piglets crushed by their increasingly large mothers, but the crates clearly give rise to serious welfare concerns for the sow due to the very close confinement imposed and the sows' inability to carry out their natural behaviours. The RSPCA has been at the forefront of funding research into viable alternatives that still protect piglets but allow sows more freedom, and we are actively encouraging the industry to use these more humane alternatives. However, at present, the farrowing crate is still legal, so the Society can take no action against those using them."*

Far from free, and confined in filth and squalor - we filmed nursing sows incarcerated in farrowing crates on an RSPCA 'monitored' Freedom Food farm.

**If the RSPCA are so disapproving of farrowing crates why have Hillside been able to film them in use on a pig farm accredited under their Freedom Food Scheme?**

**Prosecutions update**  
♦ In Norfolk, our investigators are preparing to give evidence in a case regarding cruelty to ducks on an RSPCA 'monitored' Freedom Food farm following our exposé. This case having already been adjourned FIVE times, is now to be heard (as we go to print) at Thetford Magistrates' Court on 1st April 2004.  
♦ A third man has now been arrested and awaiting charges in connection with a Hillside investigation which exposed a third illegal slaughterhouse. The two other men have been charged and are awaiting trial.

# Feeding the Nation

These are the commonplace horrors of factory farming hidden behind closed doors - often right on your doorstep

## Pigs



Freedom Food Pigs forced to sleep in their own excrement

Pigs often exist in cramped dirty conditions so overcrowded that it is difficult for them to lay down and rest comfortably. With insufficient straw bedding and sometimes none at all, the pigs have no choice but to sleep in their own excrement. We have uncovered conditions where sick, dying and dead pigs were left amongst the living, increasing the risk of cannibalism, disease and infection. Stale drinking water and discarded medical supplies such as syringes and needles are other examples of negligence and bad management practices that we have filmed.

## Battery Hens

Crammed together, five to a cage measuring just 18"x20" (45cm x 50cm) battery hens exist in these barbaric conditions for 18 months until they are

slaughtered! We have even found up to eight hens in one cage, often sharing their limited space with the decomposing remains of those birds not strong enough to survive. People who buy cakes, mayonnaise, pasta, quiches or any produce containing 'egg', are contributing to this cruelty often without realising the consequences of their actions!

## Illegal Slaughterhouses

To date Hillside Investigators have exposed **THREE** cases of this barbaric trade in animal suffering. As a result three men have been sent to prison and three others have been charged and are currently awaiting trial.



## Slaughterhouses

It is illegal in the UK to slaughter livestock in front of other animals. Despite this fact, we filmed this horrific scene in a



British EEC approved slaughterhouse. You can see how the terrified bullock, next in line to be killed, having witnessed his fate over the killing pen door (top left), makes a desperate attempt to escape unavoidable death.

## Heat Stress i

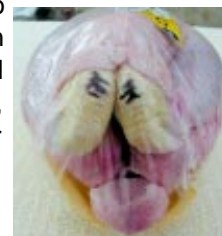


Millions of birds exist in this country, crammed together, spending the summer struggling, stifling, ammonia-ridden, with a heatwave please spare the thousands of birds who will die a slow name of duck, chicken and turkey.

## Broiler Chickens



With lights left on for 22 hours of the day these young chickens are encouraged to overeat in order to put on as much weight in the shortest time possible. Their immature legs struggle to support their unnatural body weight, and many just collapse. Many drag themselves around to reach food and water, and have no choice but to crouch on filthy, ammonia-soaked floors. As a result, many chickens suffer breast blisters and hock burns such as the example shown here.



## Sheep

We have filmed sheep with such severe foot rot that they are barely able to walk. They are regularly left untreated for long periods of time with the infection so advanced that their hooves are eaten away to an unrecognisable state (*a live sheep's infected foot is pictured above*). We have often found flocks of sheep left in the winter with little to eat, their thick woolly coats hiding their emaciated bodies.



## Dairy Cattle

A cow's udder will naturally hold about two litres of milk at any one time. However the modern dairy cow can be carrying up to TEN litres of milk. This distends the udder and because of the unnatural walking pattern, leads to lameness. These stresses along with unhygienic milking conditions means that there is a high incidence of mastitis. The early signs of this disease are often missed and somatic cells from the infection is passed along into the collected milk.

A dairy cow gives birth to a calf every year and then has to undergo the distress of being separated from her offspring, usually within 24 hours. The young male calves are often discarded and killed. Dairy herds are often kept indoors during the winter months, overcrowded and unable to exercise, in cubicles too small for them forcing their feet to remain in the slurry passage and become infected. These appalling practices are brought about by the huge demand for dairy produce, not only in its natural forms of milk, butter, cheese, cream and yoghurt, but also as an 'invisible' ingredient, (often called lactose or whey) in such things as chocolate, cereals and cakes. **Current regulations allow milk sold to the public to contain up to 1% somatic cells - commonly known as 'pus'!!**

## Freedom Food Hens

Hillside have exposed the dreadful conditions inside R S P C A 'monitored' Freedom Food, free-range egg farms. On one free-range organic unit our investigators found hens so badly feather-pecked that some had feathers on only 15% of their body. Dead and decaying hens were left to rot for at least two weeks alongside their living companions. Our vet who examined two of the hens, stated in his report: *"It was my opinion that it is inhumane to keep hens in such a state."*

## Turkeys

Like many other intensively farmed animals, turkeys suffer in appalling conditions during their short life. Thousands of birds are crammed into large windowless sheds and we frequently film turkeys left to suffer with large festering untreated wounds and painful leg deformities. Some are only able to reach food and water by dragging themselves along on their wings. The birds are left to lay in their own waste which, with its high ammonia content, often causes infected flesh burns. During catching, the live birds are often roughly handled, and crammed into crates to be transported to slaughterhouses, where barbaric slaughter practices bring their pitiful lives to a cruel end.



## Ducks without water

Ducks, like many other intensively farmed animals, are often genetically selected to gain the greatest amount of weight in the shortest amount of time in order to maximise the farmer's profits. This unnatural growth rate means their legs cannot support them and they are often left to drag themselves by their **wings through their own excrement**. Ducks find it difficult to right themselves if they end up on their backs and more often than not, unable to reach food and water, will die marooned in this position. The ducks are also denied their most basic instinct - the need to swim!

## Are the authorities BLIND, INCOMPETENT or WILFUL as they continue to COVER UP the extreme suffering of farmed animals? report by Wendy Valentine

We would just like to thank everybody who telephoned, faxed and e-mailed us to express their support for our work following the screening of the BBC1's Food Police programme in February. The programme showed the horrific suffering of turkeys filmed by our investigators in the Autumn of 2003, on a Cherryridge Poultry farm at Northrepps, near Cromer in Norfolk. Despite the fact that over a five-week period, we had filmed the same atrocious conditions on twenty-one separate occasions, Norfolk Trading Standards and a DEFRA vet could find nothing wrong.

### How events unfolded. . .

**Thursday 9th October** - the case is reported to Trading Standards who proceeded to watch two recent Hillside videos showing scenes of extreme suffering on a Cherryridge farm. Knowing the authorities were due to visit the site the next day, we filmed the farm again during the evening to confirm that the awful conditions we had reported had not changed.

**Friday 10th October** - not yet knowing the outcome of the authorities' inspection, we visited the farm again during the evening. We had fully expected all the suffering birds to have been dealt with, but were extremely surprised to find them still there and wondered whether the planned inspection had been postponed as we could not believe that any vet could walk away and leave so many turkeys in such a desperate state. The only indication that an inspection might have taken place was that the pit full of dead turkeys which were waiting to be illegally buried had been removed.

**Saturday 11th and Sunday 12th October** - as we wouldn't be able to know the outcome until after the weekend, we filmed inside the Cherryridge turkey sheds again on both days.

**Monday 13th October** - during the morning we contacted Trading Standards and were astonished at their report - *they had found no welfare issues*. That evening of 13th October, we re-visited the Northrepps farm and again filmed the same sickening sights that we had witnessed before.

**Tuesday 14th October** - we presented Trading Standards with this latest evidence. They refused to comment apart from the fact that they would no longer be dealing with the case and referred us to DEFRA. From then on, thanks to an authority's tip-off, we can confirm that at least one aspect of Cherryridge has certainly improved - their night-time security, clearly in order to prevent us obtaining further damning evidence of what is *really* going on there! Even though we knew that the Food Police programme was going to report that 'no welfare issues' were found, we were astonished to see the location of the filming in possible dispute, especially as the BBC had told us they had filmed a Trading Standards Officer confirming that he was satisfied that the premises filmed by us were those of Cherryridge Poultry, Northrepps, Cromer.

Trading Standards had clearly stated on the programme that the footage they had watched showed several welfare issues so if they questioned the location of the filming, why have they not subsequently asked the whereabouts of the 'offending' site in order to investigate it? You may be interested to know that when we had filmed this same farm three years previously (when it was an RSPCA 'monitored' Freedom Food farm) the footage taken then showed alarmingly similar conditions.

### We send 300 villagers video evidence of what was happening behind closed doors on their doorstep . . .

The BBC filmed with us for several days, including attending a Northrepps Parish Council meeting after we had sent a copy of the 'Christmas Turkey' video to every householder in the vicinity of the Cherryridge turkey farm in question. At the meeting, residents were in full support of our actions and were pleased that at last they had evidence to explain why they were constantly plagued by flies. They had previously complained and been told by the Environmental Health Authorities that Cherryridge was not responsible for the continual infestation. We were actually criticised for not using the correct protective wear to prevent the spreading of any disease, but as we only visit one farm during an evening this should not have been an issue. However, the disgusting conditions in which the turkeys are kept are more likely to be a problem to health than our 'jeans and boots' and I wonder if the *millions* of flies which have swarmed out of Cherryridge farms wiped and dipped their feet before landing on people's food?!!

**After watching the video, several villagers, who were ex-employees, contacted us and confirmed they had also witnessed much unnecessary suffering not only on this particular Cherryridge farm but also on some of their other 40 farms and in their slaughterhouse which is also situated in Northrepps. Some of these statements were recorded on film by the BBC who also conducted a lengthy interview with one employee who wholeheartedly supported our findings! Unfortunately the BBC, for reasons only known to themselves, failed to broadcast these admissions. Some workers even told us that they had contacted the RSPCA some years previously about conditions there, but had simply been ignored.**

### The authorities try to defend their actions . . .

Since highlighting this particular case in our previous newsletter some of our supporters have been writing to their MPs asking for an explanation. They in turn contact DEFRA who reply with *'This Government is committed to high standards of farm animal welfare. We have, in Great Britain, some of the strictest legislation in the EU to protect the welfare of farm animals.'* and *'Our State Veterinary Service (SVS) enforces the welfare legislation and conducts regular inspections of farm premises to check the welfare of livestock.'* If this were true and farmers lived under the threat of being prosecuted for flouting animal welfare laws I am certain that Hillside's investigators would not continue to find the appalling amount of suffering on practically EVERY farm they visit. One livestock farmer has confirmed to us that he has never been inspected by the SVS or in fact any other authority in relation to his animals. (It must be remembered that although we highlight specific farms in our quarterly newsletter we regularly take footage showing animals existing and suffering in atrocious conditions on scores of other farms ranging from smallholdings to major producers of animal products. Space in our newsletter doesn't permit giving details of all our investigations.)

A response from Steve Holland, head of Norfolk Trading Standards to a letter sent to him by one of our supporters read: *'So far as the turkey sheds are concerned, my understanding is that the footage shown on the programme had been taken three weeks prior to my officers being made aware of any problems at all. It is also unclear that the filming took place at the premises which was thoroughly inspected by my staff. On the day of the inspection, the conditions discovered bore no resemblance whatever to the appalling conditions shown on the programme. Once again, I can only re-emphasise the importance of animal welfare campaigners providing evidence in a timely manner to the statutory enforcement agencies. This did not take place on this occasion.'*

Despite his reply you can see from our account above of actual events just how Trading Standards and DEFRA had the *ideal* opportunity to catch Cherryridge red-handed blatantly flouting animal welfare laws and although Mr Holland openly admits the turkeys were in 'appalling conditions' his staff chose to ignore their desperate plight.

I have challenged Mr Holland about this statement and he reiterated that a thorough inspection had taken place and also if his staff had missed such suffering he would view the matter very seriously but he had seen no evidence to support our findings. This was despite the fact that we had delivered to his office, our footage, filmed soon after their inspection. We promptly sent yet another copy, and on contacting him a week later, he admitted that he still hadn't watched it!

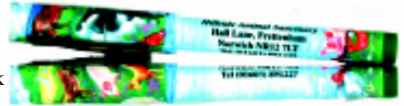

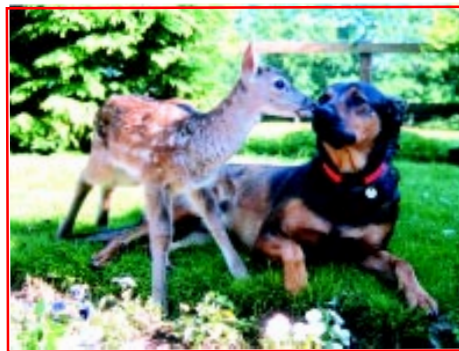

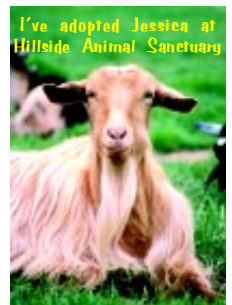
