## Bernard Matthews' workers walk free after we filmed them beating and kicking turkeys for fun . . .



"You throw them and I'll hit them," shouts the worker.

. . . they each received 200 hours community service and ordered to pay £350 towards costs.

In our last newsletter we reported how our investigator filmed turkeys being sadistically attacked with a wooden pole and then kicked on a Bernard Matthews' farm.

He shot the damning evidence while filming the general rough handling of turkeys as they were being caught for slaughter. The footage appeared on Sky and BBC news programmes all around the country and sparked outrage from an indignant public. In response the RSPCA brought a prosecution against Daniel Palmer, 27, and Neil Allen, 30, both from Dereham in Norfolk (*pictured right*). Their case was heard on 7th September 2006 when they pleaded guilty to charges of causing unnecessary cruelty to animals.

In court their solicitor, Simon Nicholls, blamed their cruel outburst on 'peer pressure' and the 'culture' at the farm.

He said the footage, which was shown in court, revealed the 'appalling' conditions at the plant. "You can imagine working in that kind of environment on a long-term basis. It must be really quite awful." He went on to explain "In this type of environment the one thing you cannot do is step outside what everyone else is doing." Our footage showed at least four other workers around at the time of the offence, none of whom seemed to object to the abuse or attempt to stop it and certainly didn't report the incident to the management afterwards! The offenders obviously knew they could carry out such an atrocity without any risk of

recrimination from their co-workers. They certainly hadn't bargained for Hillside's investigator to be on the scene!! The footage can be viewed on our website at [www.hillside.org.uk](http://www.hillside.org.uk).



## Bernard Matthews Ltd's response - a whole page advert in the 'Eastern Daily Press' which read . . .

*MESSAGE: 'You may have recently read press reports about two men found guilty of cruelty to some of our turkeys earlier this year. It is important to stress that these two men were not our employees but those of a sub-contractor whose reputation we had no reason to doubt. Bernard Matthews Limited feels very strongly that the community sentence imposed was derisory and, given the circumstances, feels a custodial sentence was far more appropriate. In court, the solicitor representing the two men attempted to excuse his clients' actions by claiming there is a culture of peer pressure at our company and that our staff work in appalling conditions. Everyone here knows that this is not true but, regrettably, the Company was not requested to be in court to refute these allegations. Many recognise that there is a small minority of individuals who are determined, by whatever*

*means possible, to discredit the production of livestock for human consumption. Clearly it is in their interest to paint a biased picture of production techniques. As many readers will know, we are a major employer in the region and the success of our business is absolutely dependent upon ensuring that we maintain high standards of animal welfare. These standards are regularly assessed by third parties, including vets. Most importantly, and in support of all our agricultural staff and employees across East Anglia, we completely refute the allegations made. Our employees are conscientious people who work in co-operation with our retail customers, local and national government authorities and various welfare organisations, including the RSPCA. They are trained in animal husbandry and do not abuse turkeys. We will not and do not tolerate cruelty to any of our turkeys.'*

This advert started another media frenzy with newspapers and television channels queuing up at Hillside for interviews. The media broadcast our response and the BBC showed scenes of turkeys suffering on yet another Matthews' farm. Although we have filmed similar welfare issues many times before, this evidence was not taken by OUR investigators but by one of Bernard Matthews' own workers who gave us the footage. We were also contacted by a lorry driver who drove trailers, loaded with turkeys, to the slaughterhouse. He'd witnessed Bernard Matthews' catchers brutally kicking turkeys as they held them upside down. When he tried to intervene he was told in no uncertain terms that it was none of his business!!

## Avian Flu and Bio-security - what *they* tell you . . .



*Extracts from Evening News 27th April 2006:*

**"Don't panic"** was the message to the Norfolk public today after bird flu was found in a flock of chickens in the county. DEFRA confirmed the first

case of bird flu in a farmed flock in Britain had been discovered at a farm at North Tuddenham.

The virus tested positive for the H7 strain – not the deadly type of H5N1 responsible for causing the deaths of more than 100 people around the world. Health bosses today stressed there was no risk to public health, but farmers fear if the virus spreads it could be disastrous for the county's poultry industry. But officials at Defra said the entire flock of 35,000 chickens at Whitford Lodge Farm will have to be slaughtered to stop the disease spreading. Police were today guarding the breeder farm, owned by Banham Poultry, while they waited for Defra to arrive.

Dennis Foreman, director of Banham Poultry, said: "We have done everything that we can to work with the powers that be and I am proud of the way staff have reacted to this situation. There is no danger to staff or people and certainly not to customers so long as the chicken is cooked. Of course, to kill thousands of birds that look healthy in the shed is soul-destroying.

**Bio-security in this country is second to none and the sooner people realise that the better. We are certainly not panicking."**

Norwich's director of public health Dr Peter Brambleby urged people not to panic. "Avian influenza is a disease of birds and for it to have an effect on humans it would need an extremely close contact with infected birds, particularly their droppings. At this stage there is still no definite confirmation that this is a virus that has human health implications. As a precaution, those who may have been exposed are being offered the appropriate treatment and protection today.

The rumour is that the bird flu could have arrived in a recent new batch of chickens coming to the

farm. A massive disinfectant lorry arrived at the farm at 9am today."

The last major outbreak of the H7 strain devastated the Dutch poultry industry in 2003, when 32 million birds were slaughtered as part of the control measures.

A spokesman for Bernard Matthews said: "Bernard Matthews is continuing to maintain the very highest standards of bio-security, which means making sure bugs don't get in and out of poultry."

Butchers said they hoped the public would realise the strain found was not the potentially lethal H5N1 strain and would not stop buying poultry. Defra officials were due to return to the farm today and an exclusion zone of up to 3km could be imposed on the farm. Everyone going in or out of the farm had to be disinfected and no domestic animals were allowed to leave without inspection."

### Coping with a bird flu pandemic

Health chiefs in Norfolk are considering banning football matches and large-scale gatherings in the event of a flu pandemic.

The move is part of a series of measures looking at slowing the spread of any virus, including household quarantines and encouraging the public to make fewer trips to the supermarket.

People with mild symptoms would initially be encouraged to go to their chemist to seek treatment.

More serious cases would either require a home visit or an admission to a specially set up community hospital.

Those most severely affected and in need of ventilation treatment would be admitted to acute hospitals such as the Norfolk and Norwich and James Paget.

Most experts agree a pandemic is more a case of 'if' not 'when', with predictions that up to 50,000 people in this country could die.

But no one yet knows what form the virus will take or whether the condition will be a new strain of H5N1 bird flu able to spread from human to human.

*Extracts from Evening News 12th July 2006:*

"Norfolk's farming community has reacted angrily to a statement from a government department linking the spread of **bird flu** to farmers feeding dead chickens to foxes.

The final report by Defra into the spring outbreak of H7N3 strain at three farms in North Tuddenham, blames foxes for spreading the disease and says poultry farmers should stop feeding carcasses to foxes.

Its report states: "The results of this investigation, together with those from a recent survey of poultry keepers, indicate that bio-security measures should include preventing the predation of dead birds by free-living species such as foxes and advocate not practising the deliberate feeding of foxes with poultry carcasses." After hearing of the report's conclusion, Stuart Agnew, a leading Norfolk farmer and former county representative on the National Farmer's Union, condemned the suggestion that farmers would intentionally feed foxes as 'stupid' and said it was impossible for farmers to do more to stop dead birds being taken by predators.

A Defra spokesman later denied it was linking farmers feeding foxes with the spread of the disease in Norfolk but rather reinforcing good bio-security advice.

Mr Agnew said: "That's stupid; no poultry farmer in his right mind would throw out poultry carcasses hoping that a fox would eat it. It is a sure fire way of drawing them to their premises."

The report states that wild birds were the most likely source of the first outbreak at Mowles Manor Farm, owned by Geoffrey and Simon Dann, around March 17, and that the spread of the disease to Pound Farm, also belonging to the Dannels, on about April 2, was probably due to contaminated workers.

It goes on to blame foxes living on Whitford Lodge Farm as the most likely cause of the disease spreading to the site on about April 15, claiming they probably fed on infected carcasses from Pound Farm.

**Geoffrey Dann confirmed that dead birds were taken away by a registered disposal company and that the farm did not lose much poultry to foxes as chickens were shut away at night."**

### Great Vigilance Over Bird Flu

*Ben Bradshaw MP (Minister for Animal Health) Smith Square, London.*

I would like to thank poultry keepers for their vigilance and co-operation during the recent avian flu cases in Fife and Norfolk.

The manner in which these incidents were dealt with was a shining example of what can be achieved when we are well prepared and when good relationships have been built up over a long period involving all who have an interest in a particular animal health threat. I would also like to thank the staff of the State Veterinary Service, my own department and all of those who have been working extremely hard around the clock on avian influenza.

The British public is also to be congratulated for ignoring some of the more lurid media headlines and continuing to support British poultry and eggs.

Finally, the new poultry register, set up in record time, has already proved invaluable for disease control in both the Fife and Norfolk cases. I do urge anyone who has not yet signed up to do so, for their own sake and the sake of their fellow poultry keepers.



### BANHAM POULTRY BIO-SECURITY/HEALTH & SAFETY INFORMATION

PLEASE NOTE – YOU MUST READ ALL THE INSTRUCTIONS LISTED BELOW BEFORE ENTRY TO THIS POULTRY SITE:

1. Wheels on all vehicles are to be disinfected when entering and leaving the site.
2. You must report to the site office and sign in when arriving/leaving.
3. Observe any site-specific restrictions and ensure that you adhere to these.
4. Clean overalls and footwear must be worn. Leave any protective clothing used at any other sites in your vehicle.
5. Ensure that you follow all P.P.E. requirements on site.
6. All standard hygiene procedures such as foot dips must be adhered to as instructed by the farm manager.
7. Only essential tools to be used in sheds. These should then be thoroughly cleaned after use on exiting the site. This will include spanners; screwdrivers; ladders.
8. Ensure that you maintain a good standard of personal hygiene whilst on site. Washing facilities are available. Hand sanitiser should be applied when entering live bird areas.

The Company will take action against any individual not complying with these bio-security requirements. If you have any issues whilst visiting this site, you must report them in the first instance to the Site Manager.



## Avian Flu - what they *don't* tell you . . .

**While DEFRA and the farming industry try to reassure us that everything is under control, Hillside has damning evidence to show that irresponsible practices by the poultry industry are putting the whole country at risk. Whilst, at the front doors of the poultry farms, awareness of bio-security has been heightened, from their backdoors, flies, which can travel up to two miles, are leaving the farms in their millions!!!**

Luckily (for people), this time, the virus isolated was the lesser H7, but should it have been the deadly H5N1 strain, the outcome could have been very different. Scientific research in Japan, where an outbreak in 2004 of H5N1 resulted in human fatalities, has shown that **flies can carry the virus in their intestines.** *(Please write to us for the full report.)* During 2003 and 2004 we filmed on farms where chickens and turkeys were being reared for three major producers, Banham Poultry, Grampian Foods and Cherryridge Poultry. Our footage shows their 'dead skips' (where dead birds are left awaiting disposal) full of decomposing carcasses in 'seas' of maggots. Our main issue then was to expose these farms' serious welfare issues where birds were existing in squalid conditions.

To expose the suffering and to show nearby residents why they were being invaded by thousands of flies we sent videos to every household in three separate villages. Many people were grateful to us, especially as some had already contacted their local Environmental Health Officer and were told in every case that the nearby farm **wasn't** to blame! We received typical comments such as 'you can't take a loaf of bread out the cupboard without a fly landing on it'. Subsequently our footage from the Cherryridge Poultry and Grampian sites, including the maggots, have been shown on BBC's 'Food Police' and C4's 'Dispatches' *(available to order below)*.

**We also have filmed evidence from 2003, 2005 and 2006 of conditions at a different site also belonging to Banham Poultry, showing maggot infested dead skips. This site at Swannington in Norfolk, is situated only about three miles, as the crow flies, from the North Tuddenham site where H7 was identified.** During this Summer we were still able to film their skips heaving with millions of maggots and flies, showing that even after the H7 bird flu scare, Banham Poultry were still operating such irresponsible procedures on their farms. Remember the statement from Dennis Foreman, director of Banham Poultry who said: **"Bio-security in this country is second to none and the sooner people realise that the better. We are certainly not panicking."**

Could it have been flies that spread the disease from one farm to another in the same village, as chickens naturally eat insects and flies as part of their diet? Our guess is, in view of the scientific evidence from Japan, that this is a more credible explanation than DEFRA's theory that it was spread by foxes. Even if this theory were correct,

the poultry industry still didn't seem to take heed. Only a few days after DEFRA released their 'foxes spreading virus' report, we were able to film dead turkeys left for days on a muck heap on a farm rearing turkeys for Traditional Norfolk Poultry. Our view is that the poultry industry's sloppy practices are not only endangering **all** bird life but **human** as well. Bird 'flu at Tuddenham was apparently only discovered several days after an unusual amount of birds had died. This means that if the dangerous virus had been confirmed there and the farms were using the usual dead skips, as at least two of them reportedly were, hundreds of nearby villagers could have been at risk from flies hatching out in decaying carcasses. To demonstrate this, in addition to filming at Swannington (population 300), during this summer, we obtained evidence of other skips full of dead poultry with the accompanying maggots on Norfolk farms. These included another Banham Poultry site near Long Stratton (population 4350) and a Kerry Foods' site at Bawburgh (population

500 plus 10,000 at nearby Costessey). We also filmed a trailer load of dead turkeys covered in flies at Bernard Matthews' site at Briston where another 1600 people reside within the 'two-mile fly zone'. From these four farms alone we

have shown how so many people could be at risk from direct contact with virus-carrying flies.

## We investigate the fly problem in Wiltshire. . .

**'Millions of flies descended on the peaceful villages of Burbage, Grafton, Collingbourne Ducis and Kingston on the edge of Salisbury Plain, causing massive inconvenience to locals and puzzlement to environmental health inspectors. Residents say they have had to sweep away piles of dead flies every morning since late July 2006. Local shops have sold out of insect repellents. The villages also suffered invasions of house flies in 2001 and 2003, but this summer's is said to be the worst, according to The Times newspaper'.** *(Extract from Wiltshire newspaper)*

You may also have seen the 'light-hearted' coverage of this invasion on GMTV and 'Richard and Judy'. Well, Mr Rob Draper, Kennet District Council environmental health officer, 'The lady doth protest too much' came to mind so we sent our 'team' to the Wiltshire villages to investigate. True to form, *(top right)*, Mr Draper denied any connection of the issue to the farming industry, but our investigators found a very different story. We now have footage of chicken houses, containing thousands of battery hens, absolutely teeming with flies. Underneath the cages, we filmed piles of chicken droppings several feet high, alive with all sorts of bugs and as anticipated, more flies. **An important point to note is that our footage was *not* taken during the height of summer but in the cooler months of autumn.**

This farm, which is situated in Burbage, is within easy reach (especially for flies) of all the affected villages (total population 3500)!!

### Reported in a Wiltshire local paper . . .

3rd August 2006

Millions of flies have descended on East and West Grafton and Burbage. Kennet District Council environmental health officer Rob Draper said that after a lengthy investigation he was no nearer establishing the cause of the problem. However, Mr Draper said it was more than likely that the plague was linked to the weather because, he said, there had been a similar one three years ago in Collingbourne Ducis. Mr Draper said: "In 2003 it was really bad in the Collingbournes and the weather was very similar." He said the problem appeared to occur when a period of wet weather was followed by abnormally hot weather. Mr Draper said his research had shown there was a fly problem in the Collingbourne area historically. He had found one newspaper cutting from 1862 in which a horse rider complained about the flies when riding through the Collingbourne Valley. Mr Draper said he had ruled out any connection with any local farms or the chicken rearing industry in the area. If we knew there was a particular link with agriculture we would work with the farmers to make sure everything was as good as it should be," he said. "When they spread manure we always ask them to make sure it is ploughed in within 24 hours. There is no evidence that farmers are responsible for it," he said. "If it's a natural phenomenon then there is little anybody can do about it."

Baron Phillips, who lives on the edge of East Grafton, said: "We have had to use fly papers to catch some of them at least. We must have gone through dozens and they have all been absolutely covered. We have six in the kitchen now and they are covered with flies." A local landscape gardener claimed he had been told the flies had probably come from chicken sheds that had been demolished. Mr Draper said he had checked on all the local farms and none had demolished any sheds or had spread manure in recent weeks. He advised families to either keep windows and doors closed in the day or to cover them with fly screens.

## RSPCA's Freedom Food Scheme

You may remember our investigation in 2003 into an RSPCA monitored Freedom Food duck farm where conditions were so appalling that the RSPCA was forced to bring a prosecution against poultry producers, Kerry Foods. Although we had hours of footage as evidence showing the real suffering, the RSPCA refused to use it in court. Instead they showed the judge footage that **they** had taken after all the sick, injured and dying ducks had been culled, resulting in Kerry Foods being acquitted. We believe that it wasn't in the RSPCA's interests, for a farm they were promoting through their scheme and supposedly monitoring, to be successfully prosecuted. We therefore found it interesting that they were able to have **our** footage shown in court, in the case of the Bernard Matthews'

workers, but had told us that they hadn't been allowed to show our footage of **their** Freedom Food promoted farm.

Since this case, the RSPCA are on record as saying (on C4 Dispatches' programme) that they no longer had ducks in their Freedom



Food scheme, but within months, they had re-awarded Kerrys their Freedom Food accreditation.

We find it incredible that despite all our efforts in bringing all this suffering to the RSPCA's attention, that we are *again*, this year, able to film ducks in distress in the Freedom Food scheme, again on a farm producing ducks for Kerrys.

## A pig investigation

During the Summer two new members of Hillside's staff viewed footage of an ongoing pig farm investigation. Although the film showed conditions that, unfortunately, we now routinely find on such farms, our two new recruits were horrified at what they saw and said that surely something must be done about it. We told them that this would be unlikely and to prove the point, contacted the RSPCA in June, with details of the investigation. Despite several requests for a report, we are still waiting to hear from the RSPCA the outcome of their visit to this farm which we filmed displaying a BQP (British Quality Pigs) notice.

Below is a report concerning the Dalehead

Foods' slaughterhouse near Cambridge where pigs from BQP farms 'end their days'. BQP have 250 farms throughout East Anglia, all of which rear pigs under the RSPCA's Freedom Food scheme.

## Pigs boiled alive at 'Freedom Food' slaughterhouse

A SLAUGHTERHOUSE is being investigated by the RSPCA after two pigs were boiled alive. The abattoir is run by Dalehead Foods. The RSPCA is investigating cruelty claims after a member of staff at the abattoir, who asked to remain anonymous, claimed two pigs had been put into a tank of scalding water while still alive. He said: "The pigs come to the abattoir and we stun them, then stick them (cut their throats) before they go into a tank of boiling water to get rid of the bristles. Twice last week they weren't stuck properly, and the pigs went into the tank alive, burning them. It's really cruel. The pigs went into a hot burning tank and it is no different from if you or me went into boiling water, it burned them and they went a funny colour." **A spokesman for Dalehead Foods confirmed pigs had been put into the water tank without being properly slaughtered on two occasions**

**and said the member of staff involved had now been sacked.** Further investigation confirmed that these incidents are isolated." He added: "Dalehead Foods is committed to the highest standards of animal welfare. The Linton site operates to the RSPCA Freedom Foods standard in addition to being independently audited by a number of other factory accreditation bodies. The procedures in place exceed minimum statutory requirements." A spokeswoman for the RSPCA confirmed a complaint had been lodged and said an inspector would be visiting the abattoir. Joan Court, a veteran animal rights campaigner said: "Pigs are extremely intelligent animals and they suffer enough being stunned - there is no such thing as humane slaughter. The fact that pigs have gone into the scalding water alive is a terrible atrocity." (Extracts from Cambridge News 12th July 2006)

# Caring for Rabbits at Hillside

by Tracy Reeve

## Housing

Contrary to popular belief, rabbits are sociable animals naturally living in groups. However, they are also very territorial so introducing new rabbits to each other has to be very carefully monitored to avoid injury from squabbles. They require spacious, draught-free and dry housing with access to the outdoors so they can exercise and graze. We always make their accommodation as interesting as possible by providing tubes (as substitute burrows) and safe rabbit toys for them to play with.

## Winter care

During the cold, wet winter months our rabbits are housed in a well-ventilated barn with spacious exercise runs.

## Feeding

Grass is always available for our rabbits during spring and summer with good quality hay available which they can enjoy all year round. Rabbit pellets provide all the nutrients needed for a healthy diet but must be fed along with hay. We also provide them with leafy greens and vegetables when available.

## Teeth

As rabbits' teeth continue to grow they instinctively chew wood to keep them naturally 'filed'. To help them achieve this we provide our rabbits with safe branches (such as apple or any tree which produces edible fruit) for them to chew and strip the bark. We regularly check their teeth to detect any dental problems.

## Vaccinations

Our rabbits are given a twice-yearly vaccine to protect them from myxomatosis.

## Parasites

We routinely treat our rabbits for internal and external parasites as part of a preventative programme.

## Flystrike

During warm weather, just like other animals, rabbits can suffer from the serious condition of flystrike. A daily check to ensure their tails and bottoms are clean and dry is vital as flies are attracted to dirty fur to lay their eggs. These, in turn, quickly hatch into maggots. We also use a special preparation to help prevent flystrike.

## Rabbits and guinea pigs

When rabbits and guinea pigs come to the Sanctuary, having already been living together in harmony, we do not separate them. However, we never intentionally pair them together as guinea pigs can be harassed by the rabbit causing them injury or even worse! We find each is usually happier in the company of their own kind.

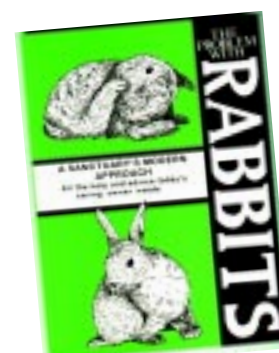
## Castration

To avoid the patter of little paws we always have incoming male rabbits neutered.



## Feet

Rabbits at Hillside have their nails regularly checked and trimmed with special clippers when necessary.
